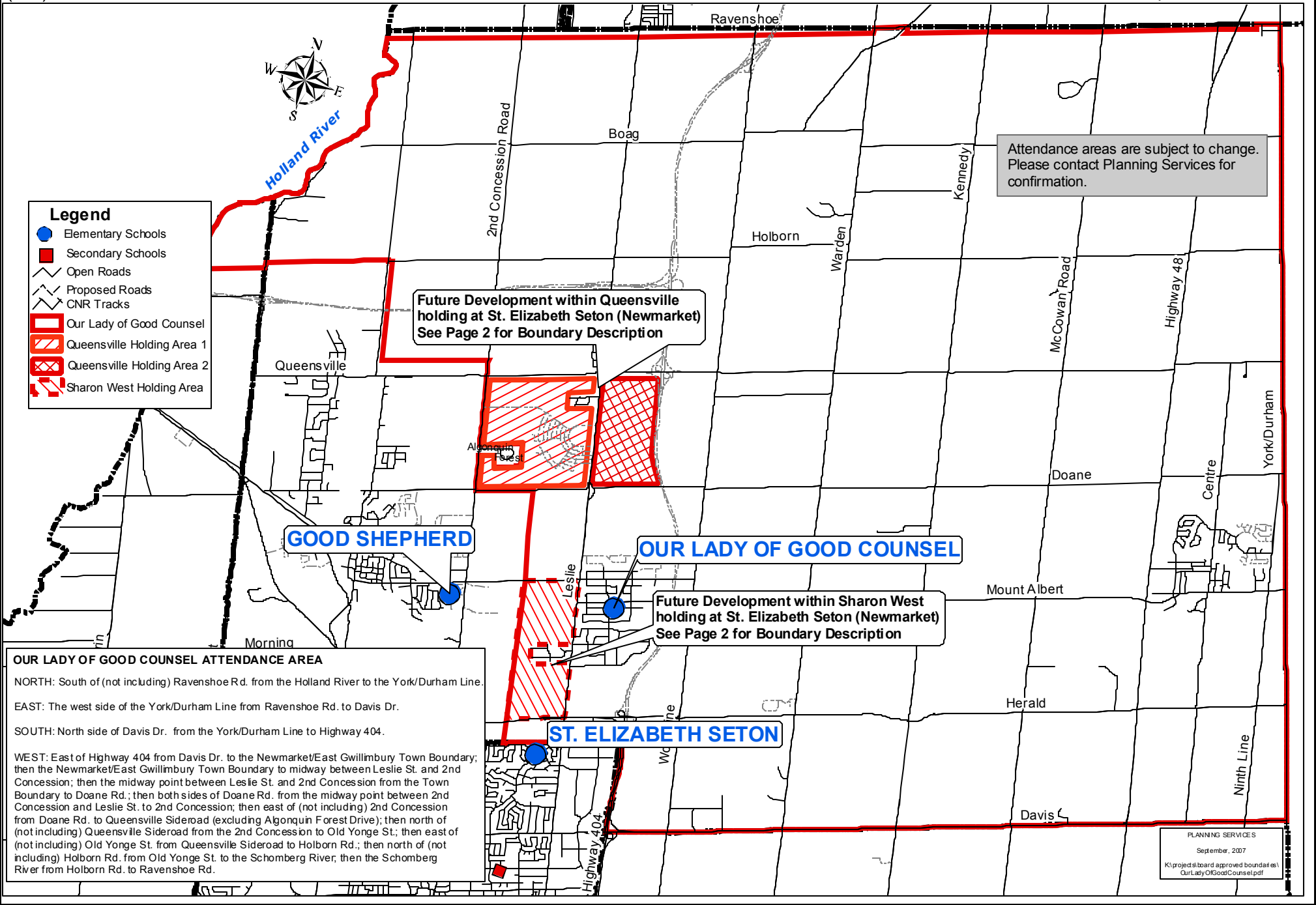

**OUR LADY OF GOOD COUNSEL ATTENDANCE AREA**

NORTH: South of (not including) Ravenshoe Rd. from the Holland River to the York/Durham Line.

EAST: The west side of the York/Durham Line from Ravenshoe Rd. to Davis Dr.

SOUTH: North side of Davis Dr. from the York/Durham Line to Highway 404.

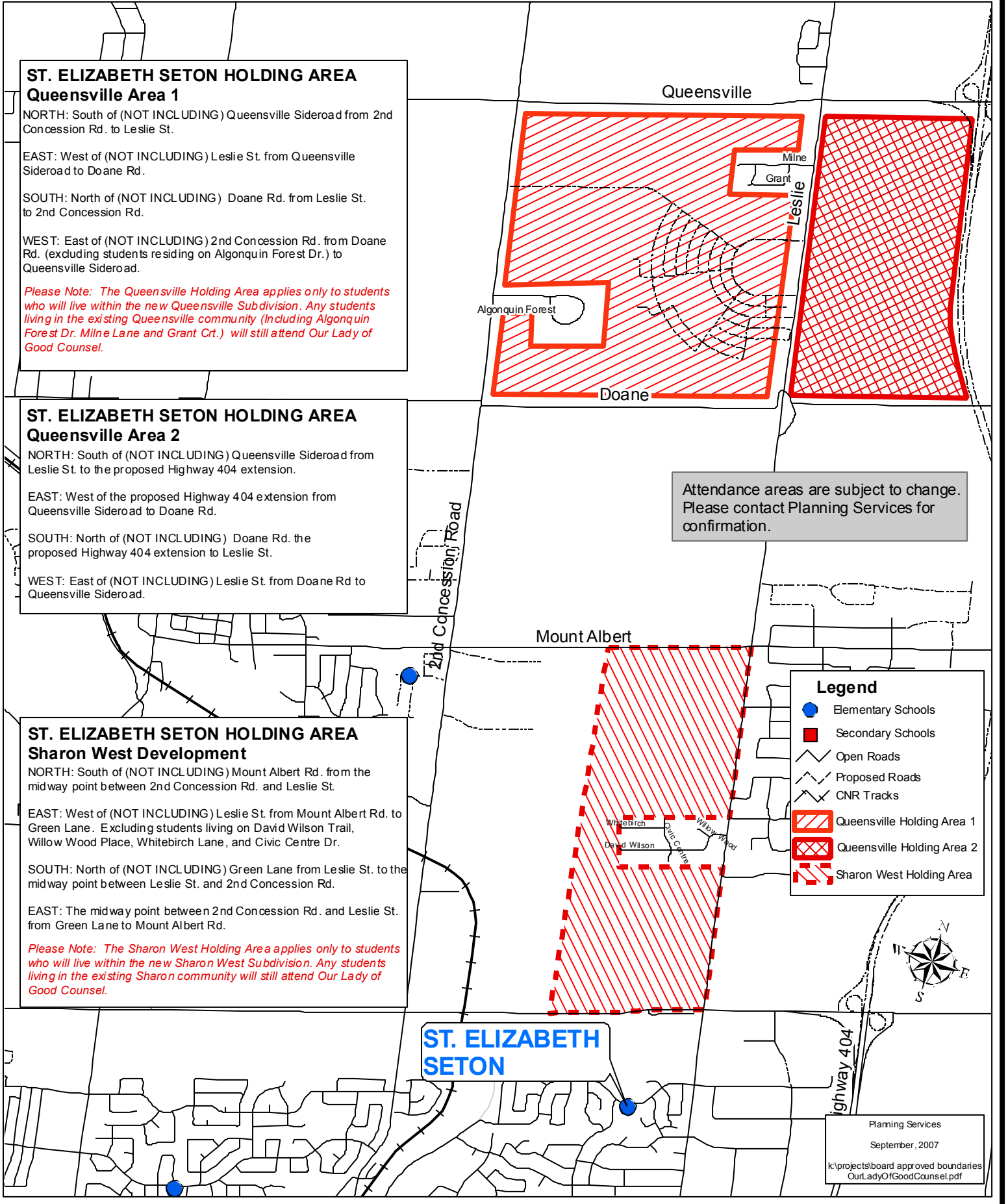
WEST: East of Highway 404 from Davis Dr. to the Newmarket/East Gwillimbury Town Boundary; then the Newmarket/East Gwillimbury Town Boundary to midway between Leslie St. and 2nd Concession; then the midway point between Leslie St. and 2nd Concession from the Town Boundary to Doane Rd.; then both sides of Doane Rd. from the midway point between 2nd Concession and Leslie St. to 2nd Concession; then east of (not including) 2nd Concession from Doane Rd. to Queensville Sideroad (excluding Algonquin Forest Drive); then north of (not including) Queensville Sideroad from the 2nd Concession to Old Yonge St.; then east of (not including) Old Yonge St. from Queensville Sideroad to Holborn Rd.; then north of (not including) Holborn Rd. from Old Yonge St. to the Schomberg River; then the Schomberg River from Holborn Rd. to Ravenshoe Rd.

### ST. ELIZABETH SETON HOLDING AREA Queensville Area 1

**NORTH:** South of (NOT INCLUDING) Queensville Sideroad from 2nd Concession Rd. to Leslie St.

**EAST:** West of (NOT INCLUDING) Leslie St. from Queensville Sideroad to Doane Rd.

**SOUTH:** North of (NOT INCLUDING) Doane Rd. from Leslie St. to 2nd Concession Rd.

**WEST:** East of (NOT INCLUDING) 2nd Concession Rd. from Doane Rd. (excluding students residing on Algonquin Forest Dr.) to Queensville Sideroad.

*Please Note: The Queensville Holding Area applies only to students who will live within the new Queensville Subdivision. Any students living in the existing Queensville community (Including Algonquin Forest Dr. Milne Lane and Grant Cr.) will still attend Our Lady of Good Counsel.*

### ST. ELIZABETH SETON HOLDING AREA Queensville Area 2

**NORTH:** South of (NOT INCLUDING) Queensville Sideroad from Leslie St. to the proposed Highway 404 extension.

**EAST:** West of the proposed Highway 404 extension from Queensville Sideroad to Doane Rd.

**SOUTH:** North of (NOT INCLUDING) Doane Rd. the proposed Highway 404 extension to Leslie St.

**WEST:** East of (NOT INCLUDING) Leslie St. from Doane Rd to Queensville Sideroad.

### ST. ELIZABETH SETON HOLDING AREA Sharon West Development

**NORTH:** South of (NOT INCLUDING) Mount Albert Rd. from the midway point between 2nd Concession Rd. and Leslie St.

**EAST:** West of (NOT INCLUDING) Leslie St. from Mount Albert Rd. to Green Lane. Excluding students living on David Wilson Trail, Willow Wood Place, Whitebirch Lane, and Civic Centre Dr.

**SOUTH:** North of (NOT INCLUDING) Green Lane from Leslie St. to the midway point between Leslie St. and 2nd Concession Rd.

**EAST:** The midway point between 2nd Concession Rd. and Leslie St. from Green Lane to Mount Albert Rd.

*Please Note: The Sharon West Holding Area applies only to students who will live within the new Sharon West Subdivision. Any students living in the existing Sharon community will still attend Our Lady of Good Counsel.*
