**GRANT DECLARATION TERMS & CONDITIONS**  
2016 – 2017 SCHOOL YEAR

These fees will be in effect for the 2016-2017 school year or until the Ministry of Education Community Use of Schools Grant has been depleted. Please note that Grant rates do not apply for permits issued for statutory and school holidays, designated PA days, Christmas, Summer & March Breaks including weekend use during school breaks, and long weekends. In order to qualify for the decreased rates, please review the following classifications:

- a) **Classification B2 :** Catholic Church Service Groups including: CWL; Knights of Columbus; Children and Youth Groups; Catholic Children’s Aid Society; Share Life.
- Facility and equipment rental fees are covered 100%  
Custodial overtime rates are covered 25% resulting in fees of: Saturday \$31.50/hr, Sunday \$42.00/hr  
Utility Surcharge fees are covered 50% resulting in a \$5.00/hr rate  
Processing fee has been reduced to \$35.00 per application
- Classification B3 :** Newly Established Catholic Church
- Custodial overtime rates and Utility Surcharge fees are covered 100%
- b) **Classification D:** Non-profit Children & Youth Community groups to include: Scouts, Guides; Brownies; Cubs; Cadets; (Voluntary Supervision).
- Facility and equipment rental fees are covered 100%  
Custodial overtime rates are covered 25% resulting in fees of: Saturday \$31.50/hr, Sunday \$42.00/hr  
Utility Surcharge fees are covered 50% resulting in a \$5.00/hr rate  
Processing fee has been reduced to \$35.00 per application
- c) **Classification D1:** Non-profit Children & Youth Sport and Recreation Programs (charging participation fees)
- Facility and equipment rental fees are covered 50%  
Custodial overtime rates are covered 25% resulting in fees of: Saturday \$31.50/hr, Sunday \$42.00/hr  
Utility Surcharge fees are covered 50% resulting in a \$5.00/hr rate  
Processing fee has been reduced to \$35.00 per application
- d) **Classification D2:** Non-profit Children and Youth Recreational Programs operated by Municipalities
- Facility and equipment rental fees are covered 75%  
Custodial overtime rates are covered 25% resulting in fees of: Saturday \$31.50/hr, Sunday \$42.00/hr  
Utility Surcharge fees are covered 50% resulting in a \$5.00/hr rate  
Processing fee has been reduced to \$35.00 per application
- e) **Classification D3:** Not-for-profit Adult Recreational Groups
- Facility and equipment rental fees are covered 50%  
Custodial overtime rates are covered 25% resulting in fees of: Saturday \$31.50/hr, Sunday \$42.00/hr  
Utility Surcharge fees are covered 50% resulting in a \$5.00/hr rate  
Processing fee has been reduced to \$35.00 per application
- f) **Classification C2:** Not- for- Profit Childcare Operations – groups involved with Before and After School childcare programs, Licensed Child Care Centres – delivered by eligible operators as per the Day Nurseries Act.
- Facility rental fees for Before and After School programs to be reduced by \$10.00 per week.  
Processing fee has been reduced to \$35.00 per application

It is understood that the reduced rates made possible through the Grant are ultimately intended to benefit each individual participant.
