a) International Education Program - Year End Review

I. Faraone, Principal, International & Continuing Education Programs and C. a) TRUSTEE MOTION: Admission to St. Theresa of Lisieux CHS (M. lafrate)

Whereas St. Theresa of Lisieux CHS is at capacity and therefore, a cap was placed on the school in

order to maintain students and staff safety and well-being;

Whereas families are transferring from public, private and other schools to St. Theresa of Lisieux

CHS feeder schools, namely, St. Mary Immaculate CES, St. Anne CES, St. Marguerite d'Youville CES and Father Henri Nouwen CES, in order to access entry to St. Theresa of

Lisieux CHS.

THAT enrolment to St. Theresa of Lisieux CHS remain capped at 1600 to ensure the safety of all students and staff:

THAT staff review St. Theresa of Lisieux CHS admission process while maintaining a fair and transparent process;

Vice-Chair lafrate thanked staff for the supplementary report. The Board of Trustees requested staff to incorporate some of the legal terms received in past years into the final report. Chair Crowe asked staff to review how the current TCH19 process giving Superintendent's discretion regarding students attending feeder schools but living outside of the boundary is being applied to ensure fairness.

b) Update on Motion to Bring Peace to YCDSB Using the Symbol of Our Faith

M. Brosens, Senior Manager, Brand, Marketing & Communications shared information about various resources that could be produced to support the Motion, "Motion to Bring Peace to the York Catholic District School Board Using the Symbol of Our Faith".

Some members of the Board brought forward concerns with the cost of the promotional material and the environmental impact if they are discarded. They thought that given our deficit the funds would be better used for classroom resources. Other members of the Board felt that the promotional material were of great value and agreed that anything that can be distributed to students with a positive message is beneficial. It was also suggested that the "We Are Diverse. We Are One in Christ." be added to all school agendas if possible. The banner concept was well received and agreed upon for distribution to all schools: one for elementary and two for secondary.

A. Battick, Interim Human Rights and Equity Advisory shared an overview of the initial phase of the Equity Audit concentrating on employment practices within the York Catholic District School Board. The audit is strategically designed to evaluate and improve our approaches to equity, diversity, and inclusion ensuring alignment with the Board's MYSP as well as compliance with Ontario's Education Act and Human Rights Code.

c) Establishing the Anti-Black Racism Advisory Committee

A. Battick, Interim Human Rights and Equity Advisory shared information on the Anti-Black Racism Advisory Committee that was formed in response to the recognized need to address and dismantle systemic and historic racism. Members of the community interested in joining the Anti-Black Racism Advisory Committee are encouraged to join by contacting the Office of the Human Rights and Equity Advisor.

d) Chromebook End-of-Life

S. Morrow, Chief Information Officer shared information on the recent developments concerning Chromebook support and lifecycle management within the YCDSB. Google determines the end-of-life for each device and the information is made public to inform consumers about the support duration for each device. It was clarified that Chromebooks do not expire in 3 years. Google has extended the life cycle for many models to receive security updates for up to ten years. Schools are encouraged to establish an evergreen purchasing plan for their technology resources.

f) Implementation of French Immersion at St. Joan of Arc CHS

L. Paonessa, Superintendent of Education for School Area B, provided an overview of the progress thus far, in moving the implementation of the French Immersion program at St. Joan of Arc CHS. Although there was good attendance at the open house and the staff at St. Joan of Arc CHS did a great job, students are not switching from Our Lady Queen of the World CA because they already made a commitment to that school. Due to lack of enrolment the program start will be postponed until September 2025.

Flying the Pride Flag at the York Catholic District School Board

I made this request years ago as a York Catholic District School Board ("York Catholic") parent. Today, I am making this request as a resident and business person in York Region, who is also Catholic, that now is the time for York Catholic to fly the Intersex-Inclusive Progress Pride flag, starting in June 2024 and every June thereafter, at its head office and at all of York Catholic's 101 secondary and elementary schools.

Each June, school boards throughout the Greater Toronto Area fly the Pride flag to celebrate the inclusion in those boards of 2SLGBTQI+ students, staff, family members, and community members. From a student perspective, inclusion improves learning because students feel more welcome and safe in a school board that outwardly, in the form of the Pride flag, displays an intention to be 2SLGBTQI+ inclusive. As a resident and business person in York Region, it is embarrassing to the residents and businesses in York Region that such a large government organization as York Catholic, which is in the heart of Ontario's most diverse area, lacks the courage and resolve to fully recognize Pride month by flying a Pride flag just like all other government organizations in York Region do.

I am not naive that flying a Pride flag will solve all issues of systemic homophobia and systemic transphobia in York Region. However, flying the Pride flag is a significant step towards making York Region a much safer and more inclusive place for York Catholic's students.

Approximately a year ago today, York Catholic students (delegates and student trustees) spoke clearly to you at York Catholic's April 2023 board meeting about the positive for students, especially 2SLGBTQI+ students, if York Catholic were to fly the Pride flag. Now is the time to act. My procedural suggestion is at this April 30, 2024 board meeting to seek a staff report for consideration at the May board meeting, and at the May board meeting you can vote to fly the Pride flag this June and every June thereafter. Thank you for hearing this delegation.

Good evening esteemed members of the board council and trustees, I extend my warm regards to each one of you. My name is Maryanne Stillo, and I stand before you today as a proud parent deeply invested in the vibrant community of St. Clare Catholic Elementary School. With four children actively engaged in their educational journey, my family's connection to St. Clare spans over seven years. From the cherished moments of our eldest daughter starting junior kindergarten, to the current presence of our youngest son embarking on his own educational adventure, and with two children in between, our family's commitment to St. Clare remains unwavering.

Allow me to illuminate a matter that weighs heavily upon the collective conscience of our beloved institution: the concerning trend of declining enrollment at St. Clare. Over the past seven years, I've witnessed a disheartening pattern of dwindling student numbers, particularly evident in our kindergarten classes. Regrettably, this trend extends beyond the earliest years, with students departing our school due to the challenges of assembling full-grade classrooms, the absence of robust peer relationships, and a lack of a variety of extracurricular opportunities ultimately impeding on the quality of education students deserve. Consider, for instance, the sobering reality of graduating classes with as few as eight students, with imbalanced gender ratios amplifying the disconnect of social dynamics within the classroom.

The shifting demographics of our community's boundaries further compound these challenges. Former bustling neighborhoods have undergone significant transformations, with once-familiar faces replaced by the silence of empty nests. Yet, amid this flux, the children of St. Clare remain steadfast in their pursuit of knowledge and belonging. My own daughter's educational journey stands testament to the trials faced by many students, navigating split classes year after year, with limited exposure to diverse teaching methodologies with students having the same teacher multiple times and fleeting friendships as classmates seek alternative educational avenues.

In light of these realities, I implore the York Catholic District School Board to consider a bold course of action: the expansion of St. Clare's boundaries to welcome new students into our fold. Such an initiative promises transformational benefits not only for our current students but for the prospective learners eager to embrace the St. Clare experience. Imagine the prospect of classrooms brimming

with peers of the same age, fostering a sense of companionship and shared academic pursuits. Envision a diverse array of teaching talents, invigorating our curriculum with fresh perspectives and innovative teaching. Picture our students flourishing not only academically but also socially, as they forge new connections and partake in a rich array of extracurricular activities. This creates a well-rounded learning environment, enhancing the overall guality of education of our students.

I am steadfast in my belief that this vision is within our grasp. With the dawn of a new school year upon us, September stands as a perfect moment to enact change. The children and community of St. Clare have demonstrated remarkable patience, but the time for action is now. Let us seize this moment to cultivate an environment where growth, positivity, and opportunity abound—a haven where every child's potential is nurtured and celebrated.

In closing, I extend my gratitude for your thoughtful consideration of these pressing matters. May our collective efforts pave the way for a brighter future for the students of St. Clare and beyond.
