2023:388 JOURNEY TOWARDS OUR VISION:

a) YCDSB Communications Calendar

M. Brosens, Senior Manager: Brand, Marketing & Communications presented the 2023-2024 York Catholic Communications Calendar that indicates a list of dates/observances, religious holidays, social justice observances, etc. This live document will assist school administrators with planning and highlighting their school's patron saint.

b) Multi-Year Strategic Plan (MYSP) Update

J. Sarna, Associate Director provided an update on the 2023-2028 MYSP. J. Sarna highlighted that the Communications Department had developed promotional material (flyer) and that it is in the process of being vetted to ensure it reflects the opinion and input of stakeholders. The Senior Team will continue to develop action plans to put in place smart goals to ensure we focus on MYSP to guide our actions to improve student learning. Updates will be provided at the December 2023, February 2024 and June 2024 Board Meetings.

b) Human Rights and Equity Office - Annual Report 2022-2023

M. Farrell, Human Rights & Equity Advisory (HREA) provided an update on the HREA achievements for the 2022-2023 school year. The information was categorized into four main areas: Advice and Complaints, Systemic Initiatives, professional Development, and External Activities. M. Farrell stated that it was her intention to create a YCDSB Advisory Committee on Human Rights & Equity and an Advisory Committee on eradicating anti-Black racism. The Board of Trustees asked that the Terms of Reference, methodology for membership be shared with them.

The Board of Trustees had the opportunity to ask questions for clarification and expressed their concerns. Ms. Farrell will incorporate the feedback received and return to the September Board Meeting with actionable items.

e) TRUSTEE MOTION: Transportation to St. Brother Andre Catholic High School (F.

Alexander)

Whereas In accordance with YCDSB Policy 203 Student Transportation Services, eligibility for

transportation to and/or from a student's school/ program and home is a function of the

eligibility requirements outlined in the policy;

Whereas YCDSB Policy 203 Student Transportation Services paragraph 3.6 provides for transportation

for Secondary French Immersion transportation to students within the host secondary

school's boundary and those students who are not "transit served";

Whereas Students attending the St. Francis Xavier CES French Immersion program have identified

the lack of transportation as a barrier to their continued participation in the French

Immersion program at the secondary level. (see attached petition);

Whereas Students of the Markham South Community deserve additional support and resources to

overcome systemic barriers to their success.

Whereas Administration is currently evaluating the new Pupil Transportation Funding from the

province, with expectations of proposing policy changes to the Board of Trustees this fall.

LET IT BE RESOLVED

THAT a Transportation exception, as has been granted St. Cecilia CES, be granted for the area known as South Markham (St. Francis Xavier CES, French Immersion Boundary) to provide student transportation to students attending St. Brother Andre CHS, for French Immersion, effective September 2023 to June 30, 2024.

Chair Alexander introduced his Motion and thanked Mr. Pechkovsky and staff for preparing a comprehensive report to support the transportation for French Immersion students of South Markham. The Board of Trustees expressed their concern with the Motion noting that this would set a precedent with other communities that are requesting the same exception.

THAT the Board of Trustees authorize a Transportation Policy Exception for all French immersion students attending St. Brother Andre CHS who resides within St. Francis Xavier CES French immersion boundary / Father Michael McGivney CA boundary;

THAT staff look at solutions with the assistance of York Region Transit;

THAT the policy exception will be in effect for the 2023-2024 school year, and will expire June 30, 2024.
