On Thurs March 8, 2018 YSSN is hosting a Community Support Information Session from 7:00 p.m. to 9:00 p.m. at the YSSN Aurora Location, 240 Edward St., Unit 3, Aurora. Mackenzie Health Centre for Behaviour Health Sciences, Central Local Health Integration Network (CCAC) and CHAP Registry/Respiteservices.com will be presenting. Centre for Behaviour Health Sciences Behaviour Clinic will discuss their eligibility criteria and referral process, as well as, the bio, psycho, social model and how it pertains to clients with an intellectual disability. Individuals will learn how to cope with challenging situations, determine a crisis and establish whether behaviour can be explained. Participants will also learn some basic safety strategies and what to do if a situation escalates. Central Local Health Integration Network (CCAC) will discuss supports and services available, as well as, their eligibility criteria and referral process for both adults and children.
