Report: Approved Speakers: Follow up to Trustee Ferlisi's "Business Arising" items presented at the November 29<sup>th</sup>, 2016 Regular Meeting of the Board

F. Bagley presented this report with the intent to provide more detailed information to the Policy Review Committee related to Trustee Ferlisi's comments and questions presented in the 'Business Arising' segment of the November 29, 2016 Regular Meeting of the Board relating to a Board-approved list of speakers. Details contained within this report provided Trustees with information, processes and procedures that Board employees apply when determining a suitable speaker, facilitator or organization for presentations and/or student participation in retreats (Independent Procedures, 2015). The YCDSB Chaplaincy Team Guidelines and Services document, contains 2-pages outlining Facilitators and Retreat Location/Centres reviewed by the Board's Religious Education Department and supported by the Archdiocese of Toronto was also provided. Finally, the YCDSB Supported Charities list, a resource for teachers and/or Administrators to secure a speaker or organization for presentation to students or staff was also provided. The committee discussed the information and suggested revisions to the appendices. F. Bagley appreciated the feedback and will present the requested information at a future Policy Committee Meeting.

The committee expressed concern with the Charities List and requested confirmation that all organizations currently reflected on the list adhere to Catholic teachings. F. Bagley continued to explain to the committee that the Religious Education department continues to update the list on an annual basis. However, most recently three organizations are presently in need of further review – 2 for having information related to abortion available on their websites and the 3<sup>rd</sup> as the organization highlights that an extremely high percentage of the funds raised go towards the charities of the organization's choice, not necessarily those selected by the school, while the remaining percentage of funds supports the operational costs of the organization. Trustees expressed their concern, and requested that these 3 organizations be removed from the Charity list immediately. The committee requested further information to be presented at the next meeting relating to the 3 charities along with detailed CEO salaries for these organizations and any other administration costs that fundraising money is used for.

F. Bagley advised that the three particular organizations would be removed from the list on January 24<sup>th</sup> until researched fully. A report back to the Committee at a future meeting regarding the charities on the list, specifically the breakdown of administration costs; CEO salaries; and, the allocation of fundraising dollars submitted from schools would be provided. Religious Education Consultants and the Communications will work together to gather this information and present their findings at the next Policy Review Committee meeting.

#### **Policy 320 DRAFT French Immersion Program NEW**

F. Bagley presented this new policy and requested feedback from the committee. The committee reviewed and discussed revisions to be included for clarification purposes within the guidelines and procedures. The committee requested that this policy not be sent out for consultation until policy; guidelines and procedures have been finalized and reviewed by the committee. The committee also requested that this draft policy be shared with the International Language Advisory Committee as well as the Student Success & Pathways Committee for additional feedback. M. Marchese opposed the inclusion, in this draft, of programming changes calling for the elimination of ILE in the FI single track schools, and that this change had no place in a draft policy in the absence of any approved Board motion to eliminate ILE from single track FI. F. Bagley will revise accordingly, consolidate the feedback and input from the ILE Advisory Committee and the Student Success & Pathways Committee and present at a future Policy Review Committee meeting.
