YCDSB Coordinating Manager of Planning and Operations T. Pechkovsky called the meeting to order at 4:00 p.m.

DECLARATION OF CONFLICT OF INTEREST

INFORMATION ITEMS

Student Transportation Services York Region (STSYR) Service Update

STSYR Manager N. Smith provided a year-to-date service report for STSYR. N. Smith reported that despite driver shortages, traffic, and construction delays, the on-time performance has improved from 92 per cent in September 2023 to 98 per cent as of February 2024. STSYR staff and operators continue to work together to ensure optimal service delivery.

Recruitment and Retention Bonus

Manager Smith updated the Joint Board Consortium regarding the Recruitment and Retention Bonus (RRB) introduced in the 2023-2024 Student Transportation Grant. Funding for the RRB allocated \$2,363.00 for each school bus route based on routing simulation results. The Ministry of Education (MOE) directed school boards and consortia to flow the allocated funds to operators to administer these payments. The estimated cost for the 2023-2024 school year is \$2.5M for both boards. The flow of funds is an added cost to the YRDSB and the YCDSB.

Transportation Eligibility Parameters

N. Smith reported on the eligibility parameters set by the MOE and school boards throughout the province. The MOE introduced a revised Student Transportation Grant for the 2023-2024 school year that establishes common reference standards, including home-to-school distance criteria, for funding student transportation services across the province.

STSYR staff have analyzed the estimated financial and operational impact of changes to the Board's respective distance eligibility parameters. The elementary student distance parameters vary throughout the province. At this time, administration continues to support a collaborative, simultaneous review of the transportation policies of the two respective school boards.


SUBJECT: STSYR Organization Structure

Executive Summary:

This report intends to provide the Joint Board Consortium with an update on the organizational changes within Student Transportation Services of York Region (STSYR). Over the last year, STSYR has experienced several staffing changes. By May 2024, STSYR is projected to be fully staffed.

Revised Organizational Structure:

Chart 1 illustrates the updated organizational hierarchy of STSYR.



Summary:

Recent staffing vacancies have prompted a review and subsequent revision of STSYR's organizational structure. As of May 2024, STSYR will be fully staffed under the revised hierarchy. The restructured hierarchy will enhance STSYR's capability to address the evolving student transportation environment in the province and continue to ensure safe, efficient, and reliable service for the students of York Region.

SUBJECT: 2024-25 Transportation Budgets

Executive Summary:

This report intends to provide the Joint Board Consortium with an update on Student Transportation Services of York Region's (STSYR) budget preparations for the 2024-25 school year. The transportation budget is comprised of general administration and operating expenses for the York Catholic District School Board (YCDSB) and York Region District School Board (YRDSB).

Budget Preparations:

Administration has developed the 2024-25 transportation budgets considering the following factors:

- STSYR organizational structure;
- The opening of two new YRDSB schools and one replacement school;
- Program and boundary adjustments across both boards;
- Increases in contracted rates;
- Ministry of Education requirements;
- Fluctuations in fuel costs and taxi rates: and
- Routing efficiencies.

Summary:

According to the STSYR Operations Agreement, each board is responsible for their share of the operational expenses of the transportation budget. Administration and overhead costs are evenly split between the boards on a 50/50 basis. The budget estimates for 2024-25 school year reflect current service levels and school board policies.

SUBJECT: STSYR Terms of Reference

Executive Summary:

The intent of this report is to provide the Joint Board Consortium (JBC) with the current Terms of Reference.

Background:

The Terms of Reference (Appendix A) outline the structure, mandate, and scope of the Joint Board Consortium. Specifically, the Terms of Reference outline:

- The Consortium's mandate;
- Student Transportation Services of York Region's responsibilities;
- Dispute resolution clauses;
- Committee Membership; and
- Staff Resources.

Summary:

Administration has reviewed the Terms of Reference to ensure they continue to enable the consortium to fulfill its mandate of providing safe, efficient, and on-time transportation for all students in accordance with Board policy. Administration will review the Terms of Reference regularly on a three-year cycle.

Appendix A: The Joint Board Consortium/ Transportation Services Terms of Reference

TERMS OF REFERENCE - 2024

THE JOINT BOARD CONSORTIUM/TRANSPORTATION SERVICES

STANDING COMMITTEE:

The Consortium is a mechanism that both the YCDSB and YRDSB (hereafter the 'boards') use to amalgamate common services, such as transportation to reduce overall costs through elimination of duplication, improvement in management practices and achieving economies of scale.

The Consortium provides transportation staff the necessary operating parameters to efficiently and effectively implement transportation services, as well as recommend and implement changes to achieve savings.

Mandate re. Transportation Services:

The Consortium will assume responsibilities for the following areas with regard to transportation:

- Reporting and making recommendations to each Board
- Policy direction and development
- Appeal process
- Procurement of service and establishing rates
- Approval of school bell times
- Budget recommendations and financial control including cost allocation
- Management and evaluation

Operations:

The Student Transportation Services (STS) is responsible for all daily operation concerns including safety, route planning and organization, school and community liaison, operator evaluation, and budget development. STS Staff also provide data and policy advice to the Consortium and resource support at meetings of the joint body.

Dispute Resolution:

Any dispute between or among the boards or between the boards and any party to any agreement which cannot be resolved by the boards and such party (hereafter the "parties") shall be referred to mediation for mandatory Alternative Dispute Resolution, and a Mediator shall be selected and approved by the parties, and such mediation is to take place within thirty (30) days of such referral. Any dispute between the parties which cannot be resolved by such mediation shall be submitted for determination by arbitration pursuant to the Arbitration Act of Ontario (the "Act"), in which case the following provisions shall apply. The parties may at any time give written notice to the other of its desire to submit such

dispute to arbitration stating with reasonable particularity the subject matter of such dispute. Within five (5) business days after receipt of such notice, the parties shall appoint a single arbitrator with appropriate experience to determine such dispute. If the members fail to appoint an arbitrator, the parties may apply to a Judge of the Superior Court of Justice to appoint an arbitrator to determine such dispute. The costs of the arbitration shall be paid by the party or parties as determined by the arbitrator, which jurisdiction shall include the determination of the costs to be paid by the unsuccessful party. The award of the arbitrator shall be final and binding upon the parties. Judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction and enforced in the normal course.
