**2023:316 CHAIR'S REPORT / UPDATE / INSPIRATIONAL MESSAGES:**

Frank Alexander, Chair of the Board provided his report in the June 20, 2023 Regular Board Agenda package. Topics included: Student Trustee Anthea Peta-Dragos, Press Conference, Director's Council, Graduation Ceremonies, Summer Vacation.

In recognition of Student Trustee Anthea Peta-Dragos last Board Meeting, Chair Alexander read aloud the following section of his Chair's Report.

*"It is with mixed emotions that I share that we are losing a passenger on our journey. Tonight, is the final Board Meeting for Senior Student Trustee, Anthea Peta-Dragos, as she has completed her term as Student Trustee for the YCDSB. Anthea's enthusiasm, positivity and intelligence have made our work as a Board much more enjoyable and productive. I want to particularly thank Anthea for her leadership in advancing a number of equity initiatives, notably in her work on the Menstrual Hygiene Committee, the Mental Health Committee and in creating an executive position to represent Indigenous students on the York Secondary Catholic Presidents' Council (YSCPC). Anthea has become an excellent mentor for student leaders across the country, including for Student Trustee James, who will become the Senior Student Trustee next school year. Anthea, we will greatly miss having you at this table, but we are excited that you will soon start your next adventure at Western University in London, Ont., where you will study Health Sciences. We are also proud to note that Anthea has been awarded the prestigious Western National Scholarship - Faculty Entrance Award, as well as the National Scholarship Study Abroad Award. The Western National Scholarship is awarded to students for all-round excellence, including in academic achievement, creativity of thought and service to others. These are Catholic School Graduate Expectations that we know Anthea exemplifies. Thank you for your excellent service, Anthea, and may the Lord bless you abundantly in all your future endeavors."*

**2023:317 OCSTA / BOARD OF DIRECTOR'S UPDATE:**

Trustee Jennifer Wigston, OCSTA Regional Director representing York Catholic District School Board advised that she had just received a copy of the Board Meeting Highlights and would share with Trustees via the Trustee Weekly Update.

Trustee Wigston brought Bill 98 to the Trustees' attention indicating OCSTA is in the process of developing responses to three draft regulations, due July 5<sup>th</sup>, that have been posted by the Ministry of Education. As well, OCSTA has just released a learning module for Catholic Trustees developed especially for Catholic Trustees called, Equity, Diversity and Inclusion, and Our Faith, the Law and Anti-Racism. The faith segment features a video presentation by His Eminence Cardinal Thomas Collins. The second segment features a presentation by former Catholic Trustee and current Justice of the Peace, Karen Valentine. Each segment includes reflections, questions and supplemental resources.

**2023:319 STUDENT TRUSTEES' REPORT:**

Student Trustee Jonah James reported as follows:

*"From May 27th to June 1st, 22 YCDSB student leaders had the opportunity to go to the great big flat province of Saskatchewan on a mission of reconciliation. Student trustee Peta-Dragos and I had the privilege of being a part of those 22 leaders. The trip which was organized by the board took students to Regina and Saskatoon, where students had the opportunity to gain a deeper understanding of reconciliation and learn many lessons about how Reconciliation can be done in a deep, meaningful, and sacred way. Students were on a mission to discover how we can rebuild our relationship with our indigenous brothers and sisters, and ultimately create a school community that can provide the best possible education. We will later see a presentation about the trip, but if I were to take one thing away to tell you all as leaders of our school community, it would be that when Indigenous teaching is embraced and built into how we teach our kids, the quality of education it provides is truly amazing. We were all amazed by how reconciliation transformed Saskatchewan, and the group of 22 students is eager to work with you all to make York Catholic a board that is a leader in reconciliation, and in providing outstanding Catholic education.*

*We'd like to thank Ms. King, Mr. Galatianos, and Mr. Scuglia for organizing this once-in-a-lifetime trip, and for Trustee Wigston, and Trustee Crowe for accompanying us on our journey. On June 8th, high school students across the board decided to walk out against the board's decision not to raise the Pride flag. All students have the right to demonstrate their democratic rights and protest for what they believe in a peaceful fashion.*

*Well, today marks the last Tuesday of the school year. Students have already begun writing their final exams. Students have been working hard over the past semester, and have been fighting through the all-too-common burn-out that second semester brings. As students finish up the last days of the school year, we want to thank everyone for the amazing year we had. We all as a community went through many highs and lows. But what remained consistent was our dedication and drive for academic excellence, and commitment to making sure our schools have communities that help others thrive. We are so inspired by all the students. Coming out of the pandemic, students had a hard battle to fight. We learned a lot about ourselves, and as a result, we grew as individuals and truly became better students. Once again, we want to thank the students of the 2022-2023 school year for an amazing year.*

*Finally, the class of 2023. You've had a very different and difficult high school experience. You've only had 1 and a half years of real high school experience. You've faced lockdowns, isolation, and heavy grade inflation before your grade 12 year. But nonetheless, you conquered the school year, despite all the odds. The class of 2023 is truly one of the strongest, if not the strongest graduating classes ever. You are all champions in what you do, and the sky is truly the limit for you all. We'd like to wish the class for 2023 the best of luck in their future endeavors and thank them for the dedication they've demonstrated throughout their time here at the YCDSB."*

Student Trustee Anthea Peta-Dragos reported as follows:

*For students, the month of June represents an exciting time of the year when school clubs, committees and councils wrap up their activities, an opportunity to reflect, plan ahead and celebrate achievements. Our Grade 8 and Grade 12 graduating students are ready to throw their grad caps into the air and toss their tassels to the side! Congratulations Class of 2023 on this important milestone in your lives! Student Trustee James and I wish you all the best in your future journeys!*

*On June 5th, 2023 we celebrated the 2023 YSCPC Leadership and Board Recognition Awards, the much-awaited annual event that recognizes excellence in our schools. I would like to extend our thanks to the Director of Education Domenic Scuglia and the YSCPC Teacher Advisors who made this event possible in person this year, as well as to all trustees, senior admins, teachers and principals who attended the event and honored us with their presence! Students were extremely proud to be recognized for the leadership, resilience, effort and dedication they invested!*

*This being my last Student Trustee report, I would like to say a few words.*

*It was May of 2021, in the middle of a global pandemic, when I was elected as the Student Trustee, a time when the entire educational system suffered an unexpected shift to technology-delivered instruction. I am completing my term today delighted to see that we are able to celebrate our graduations and achievements again in person. What a journey! During this time, we navigated not one, but two transitions to and from online learning, which greatly impacted the work and well-being of students, teachers and administrators. The past two years have been filled with many changes and some of the highest levels of stress, frustration and burnout. During all this time students have demonstrated resilience, courage, determination and remained committed to achieving their goals! Their strength inspired and motivated me to implement board-wide initiatives to address students' needs, with a focus on the following main objectives:*

- 1. Eliminate **mental health stigma** and support students' access to mental health resources, by promoting acts of kindness, engaging students to participate in mental health discussions and conferences such as the Horizons Conference and Mental Health Panel Discussions.*
- 2. The implementation of the **Menstrual Hygiene Project** in all 16 YCDSB high schools. As a result of Student Trustee advocacy and a partnership between the Ministry of Education, Shoppers Drug Mart and the YCDSB, starting with May 29, 2022 all students have been offered free menstrual hygiene products in schools. This year, on May 28, 2023, our entire YCDSB community celebrated one year since the successful implementation of this project in all 16 YCDSB high schools! It was great to notice the immense progress in students' levels of comfort in talking about menstrual health, combating stigma around menstruation and creating a more equitable educational space.*
- 3. Support the **YCDSB Indigenous students** to have their voice and perspectives better represented at the board table by proposing the implementation of a **designated Indigenous Student Executive seat on the YSCPC starting with this school year**. This initiative supports the creation of an equitable system that honors the Indigenous community, supports reconciliation and enhances students' knowledge about First Nation, Metis and Inuit cultures. In June I had the honor to participate in the "**YCDSB Mission to Reconciliation**", a unique experiential learning opportunity that created an authentic, emotional connection between participants and the Indigenous community, as well as a deeper appreciation of the Indigenous community, their interest, passions and values. This represented an outstanding opportunity to listen, learn, reflect and bring back ideas to our schools of how to support all students to effectively advance on the path to Truth and Reconciliation. Student Trustee James and I would like to express our gratitude to the entire Board of Trustees and to Director Scuglia for offering students such unique and meaningful learning opportunities!*
- 4. Enhance students' participation in **environmental sustainability activities**, through the "**Lead by Example Action Project - Plant a Tree with Us**", an initiative of the incoming YSCPC President Dabria Peta-Dragos, where YCDSB student leaders participated in a community tree planting event organized by the **Town of Aurora**. **The initiative will be** offered in other schools of the York Region next year.*
- 5. Enhance **Equity, Inclusion, Diversity** in the YCDSB schools. As a member of the Ontario Student Trustee Association (OSTA-AECO) Equity and Inclusion Working Group, I collaborated with a group of Student Trustees across the Province of Ontario to educate students on topics related to equity such as anti-racism and 2SLGBTQ+ issues, and advocate for equitable and inclusive practices in Ontario education. I strongly believe and advocate for each student to feel welcomed, valued and supported in the YCDSB schools, no matter of race, ethnicity, disabilities, gender or identity. In support of the **2SLGBTQ+ student community across the YCDSB**, Student Trustee James and I put forward a motion for the raising of the progress flag at the YCDSB during the month of June 2023. Our commitment to represent the student voice at the board table, courage and advocacy work have been commended by the **Honourable Marci Ien, Canada's Minister for Women and Gender Equality**, who invited me to join the Pride Flag Raising Ceremony on June 8th on Parliament Hill.*

*After 14 years spent at the YCDSB and after 2 years spent in my role as a Student Trustee, it is time for me to say goodbye! I am so grateful for the learnings, love and kindness that I have been surrounded with over the past years. I would like to thank everyone who walked next to me on this journey! Student Trustee Alessandro Casbarro and Student Trustee Jonah James, two amazing*

*leaders, I am very proud of our accomplishments! Thank you to each and every YSCPC Executive! Best wishes for a bright future, your dreams are getting closer and closer! Thank you to the YSCPC Teacher Advisors, the YCDSB Mental Health Lead Michelle Prinzo, YCDSB Human Rights and Equity Advisor Michelle Farrell, Director of Communications Mark Brosens, Superintendents Sawicky and Chiutsi, Ms. Greco, Associate Director Sarna and Director of Education Domenic Scuglia and Trustees! Without your guidance and advice, we could not have been able to support students during all of this time!*

*As for the future, I am excited to join the Health Science Program at Western University in fall! I will carry with me forever. the learnings and love that I have been surrounded with. The York Catholic District School Board has had such a huge impact on my life and I will never forget it! From the bottom of my heart, THANK YOU YCDSB!! This concludes my final report as a Student Trustee!"*

**b) Beyond the 94<sup>th</sup> Reconciliation Presentation**

N. Galatianos, Student Success Specialist and Principal of Indigenous Education and K. King, Indigenous Education Consultant provided a presentation of the 95<sup>th</sup> Call to Reconciliation-ACTION Saskatchewan Trip 2023 from May 30 to June 3, 2023. Students that had the opportunity to attend this excursion and provided highlights from their trip noting that this was once in a lifetime opportunity to expand their horizons and learn about Indigenous people while being immersed in their communities with hands-on activities. Highlights from their itinerary were shared where they had an opportunity to hear Chief Cadmus Delorme and Archbishop Don Bolen at the CCSTA Conference. The students also had the opportunity to visit Regina Indian Industrial School, participate in Tipi Raising, visit the RCMP Heritage Centre, Visit the Royal Saskatchewan Museum, Visit Wanuskewin Heritage Park and take Hoop Dancing Lessons. They also visited Sacred Heart School, Oskayak High School. Students will now return to their respective schools with a new perspective on inclusivity and diversity within their schools while supporting Indigenous people aligned with the Papal visit, the letters from the Canadian Bishops, and the Truth and Reconciliation Calls to Action.

**2023:322 JOURNEY TOWARDS OUR VISION:****a) 2023-2028 Multi-Year Strategic Plan (MYSP)**

J. Sarna, Associate Director presented the 2023-2028 MYSP with a new Mission (*With Jesus Christ as our model, we provide all students with a Catholic education rooted in equity, well-being and learning*), Vision (*A recognized teacher in Catholic education committed to inclusion, excellence and innovation that develops socially responsible global citizens*), Core Values (*Catholicity, Equity/Diversity/and Inclusion, Excellence, Fiscal Responsibility, Integrity, Respect*) and Strategic Commitments (*Catholic Faith, Equity and Inclusion, Student Achievement and Well-Being*).

J. Sarna highlighted that each Strategic Commitment has a Strategic Priority with Goals and SMART Goals that will be measured by year one. Three goals were identified for Catholic Faith, three goals were identified for Equity and Inclusion, four goals were identified for Student Achievement and three goals were identified for Well-Being. J. Sarna further stated that the next step is to operationalize the goals and make them a reality – where are we going to allocate resources, what data are we going to measure our success? It was noted that in order to make this a reality, funds are required and Chief Financial Officer committed to investing funds where needed.

Staff was asked when they report on Goal #2 for Equity and Inclusion, to include what did we do in order to achieve the reduction in behavioural incident student reports.

The Board of Trustees had the opportunity to ask questions for clarification and were pleased that the MYSP had SMART Goals identified. It was noted that the SMART goals are the first year of the Board's Improvement Plan that once operationalized will make the MYSP come to life.

Align program initiatives with the global competencies and future trends in education and the workforce.

**Offer** inclusive and specialized programs that address and engage all student learner profiles.

Provide equitable access to evidence-based culturally-responsive services and resources for all.

**Support** ongoing individualized accommodations that support staff to perceive that their working conditions and environments are healthy, safe and inclusive.

**Foster** a culture of ongoing professional development to increase mental health literacy and enhance staff efficacy to improve employee engagement and support student well-being.

#### **b) 2023-24 Estimates – Financial Position**

C. McNeil, Chief Financial Officer and Treasurer of the Board and K. Scanlon, Budget Manager presented the 2023-2024 Financial position for the York Catholic District School Board. The 2022-2023 forecast was a deficit of \$12M as a result of the labour costs associated with Pay Equity. The overall 2023-24 estimates for compliance in-year position was (\$11.8M). A summary of the overarching budget pressures resulting from absenteeism, declining enrolment, pay equity and budget pressures impact was provided. Highlights of the YCDSC 2023-24 budget included investments to strengthen school leadership and to mitigate cyber-risk; labour costs updates related to pay equity; funds for Multi-Year Strategic Plan initiatives including supporting equity and inclusion and cost savings measures in certain areas (supply staff, facilities, maintenance, etc).

The Board of Trustees had the opportunity to ask questions for clarification. Trustees asked for a regular report to ensure funds allocated are being used in an effective way with regards to absenteeism.

- Whereas** a process for School Bell Time Management was developed and presented to the Joint Board Consortium dated June 2015. It recommended that parents were notified no later than December for changes to be implemented the following September;
- Whereas** the implementation of the process was postponed indefinitely, i.e., never implemented, because Student Transportation Services wanted to implement new routing software which would make modeling easier;
- Whereas** the new transportation funding model did not adequately address the YCDSB transportation funding shortfall.
- Whereas** the Board has a deficit and other Boards have found significant savings by undertaking a system wide review. For example, Durham DSB and Durham Catholic DSB saved \$1.9M in 2017 and took 48 buses off the road after implementing a system-wide bell-time review. In 2022-23 they undertook a second study to find further savings since school demographics and riderships had changed.
