LTAP Overview

- The Long Term Accommodation Plan (LTAP) is a comprehensive, multiyear document that guides future accommodation planning needs and initiatives.
- The LTAP is a key piece of the Board's Multi-Year Strategic Plan and is guided by Ministry of Education legislation and expectations.
- The goal is to provide an overview of planned initiatives in our school communities so families and partners are aware of what to expect in the coming years.
- The majority of the initiatives will each have their own consultation and approval process (e.g. Boundary Reviews).
- The LTAP also helps guide capital investment, program or facility decision

Survey Results Overview



Survey Key Summary

- 428 responses received across all review areas (all municipalities); most responses from those residing in the City of Vaughan (~41%)
- Vast majority of respondents have children within the YCDSB (~91%)
- The top challenge/concern that respondents shared is regarding programs (i.e. availability of programs) with common suggestion to improve availability of programming at more schools (i.e. FI, PACE, ASD, Arts, Sports, STEM, Trades, more support with core resources, etc.)
- Based on a ranking system, the top 3 priorities, from highest to lowest, that respondents felt should be addressed in the event of Pupil Accommodation Review would be:
 - 1. Prioritizing the number of schools with low facility condition
 - 2. Combine two school communities without need for portables
 - 3. Areas with most surplus capacity



Survey Key Summary

- When addressing small schools, of written responses received, many respondents suggested combining schools as an option, while allowing students to access the bus if they are moving to a school farther away; shifting boundaries was also another popular comment
- About 88% of people were most satisfied to neutral with the information provided in the LTAP for their review area
- Lots of very specific or individualized comments overall; general themes from written response were:
 - Upgrading facilities (e.g. Air conditioning in schools);
 - Improve transportation options (e.g. easier to qualify for bussing)



What did we do with Survey Results?

- Grouped into major themes and addressed them in LTAP document by providing additional information and clarification. List of changes in Appendix of Report.
 - For example, a major theme of comments was for more availability of programming (e.g. FI, PACE, ASD, STEM, Arts, Sports, Trades, more support with core resource, etc.) at more schools. YCDSB will continue to review the possibilities of additional programming and its availability but note that increasing availability of programming at more schools is challenging due to interest in these programs, appropriate class sizes and finding/having specialized staff for these programs.



What did we do with Survey Results?

Changes in Section 5.5 Pupil Accommodation Reviews:

More clearly outlined the next steps when the moratorium on school closures is lifted by the Province:

- "Update of a revised Policy 713 Pupil Accommodation Review
- Development of a Pupil Accommodation Review Strategy to identify communities and timelines of various reviews.
- Development of the required "Initial Staff Report(s)" for specific Pupil Accommodation Review(s).
- The Pupil Accommodation Review Strategy will be guided by the responses received from the public...specifically the prioritizing of the Pupil Accommodation Reviews will be based on schools with low facility conditions and excess pupil places (combining two schools without need for portables and areas with most surplus capacity.)"
