OPENING REMARKS

York Region District School Board Chair R. Lynn advised that the Boards reviewed their Education Development Charge policies and received the background study relating to the proposed successor by-laws. Chair R. Lynn stated that the purpose of the meeting was for the Boards to receive further information about the proposed by-laws in order to consider passage. Implementing Education Development Charges provides Boards with a source of funding for new school sites and is calculated based on new pupils that will be generated by housing over a 15-year period.

York Catholic District School Board Chair E. Crowe outlined that in order to pass new Education Development Charge By-Laws, the Boards must receive approval from the Minister of Education for the Boards' pupil place projections and estimates of the numbers of school sites used in the calculation of the charges. These approvals were received on May 14, 2024 and May 16, 2024.

York Region District School Board Chair R. Lynn introduced J. Easto of Keel Cottrelle LLP. Mr. Easto introduced Buck Sulley of Keel Cottrelle LLP and J. Ammendolia from Watson & Associates.
