Specific Statement of Issue

Hello everyone, my name is Mario Greco. I am a former student of York Catholic District School Board, and a current teacher in Ontario. Do we put the pride flag up on the flagpole of YCDSB schools? That might be the question tonight, but the answer to that question is based in another question.. What can we do to effectively show our love and respect for our gay and trans students as they live in the Catholic faith. I believe we should first look toward our Lord and Saviour, Jesus Christ. He died and rose from the dead to save us ALL from sin, regardless of our orientation. He is the true representative of love and respect, to ALL people. Now today you have people urging for pride flags to be raised at Catholic schools to promote love and respect to gay and trans people, as if the image of Christ doesn't already do that. Are they saying that Christ's sacrifice is insufficient or somehow inapplicable to gay and trans people? To me, that sounds extremely homophobic, and a faithless insult to Christ's sacrifice and love for ALL His people. If we truly want to serve our gay and trans students, and help them remedy whichever challenges they're burdened with, then we need to open a solution-focused dialogue with them and the community at large, with the teachings of Christ as our focal point. Raising a pride flag is not a solution-focused remedy. If a student is harassed or assaulted on the basis of who they're attracted to, waving a pride flag will not stop that from happening. What will stop that from happening, is to steer our anti-bullying efforts away from ineffectively basking in do-nothing symbolism, and instead steer our efforts toward building the confidence, self-esteem, and conflict resolution skills of ALL students. We must also remind our students of Christ's call for all people; to know that they are unconditionally loved by God regardless of who they are, and to love others unconditionally just as He does for us. This is the very call that we must apply in our solution-focused dialogue with students, including of course, those who are gay and trans; just as we do for students of other identities such as autism. You don't hear of loud fruitless calls to raise an autism flag every year at every school for an entire month; you hear calls for concrete strategies to properly foster their growth, development, and personal sense of value. Our students deserve not empty fanfare, but firm and applicable resolve; and our gay and trans students deserve this just the same. Hence why raising a pride flag is not only irrelevant, but a distraction from meeting this goal. Furthermore and more concerningly, the pride flag also carries a fornicative and debaucherous payload that is absolutely contrary to the faith, which again has no impetus on the practical solutions needed to effectively support the well-being of all students, including those who are gay and trans. So why the pressure to raise the flag? I believe it's because organizations such as Pflag threaten to label our board this Thursday as being "unsafe" for gay and trans students, unless what they call "meaningful action" takes place. However, Pflag York Region President Tristan Coolman later clarified that this "meaningful action" entails more than just raising a flag, it entails conversation and action to support gay and trans students. To that, I say that I 100% agree with Mr. Coolman. Let's engage in conversation and solution-focused action to support our gay and trans students. Merely raising a pride flag is not a substitute for it. So as long as we put our energy toward addressing the concerns of our gay and trans students and staff, there should be ZERO reason as to why Pflag would deem this board "unsafe" for gay and trans students. So thats where I implore for our Catholic school board trustees to NOT cave into the coercion of permitting the pride flag to be flown at our Catholic schools, and to instead assert

themselves on a willingness to engage in dialogue of finding concrete solutions that will help remedy any plights that our gay and trans students may be facing. But if organizations like Pflag still choose to label this board on Thursday as "unsafe" despite our willingness to engage in the more important dialogue that the Pflag President called for, then it would be clear that organizations like Pflag are lying; that their goal does not regard evoking a conversation and action plan to support our gay and trans students, but to specifically raise a flag on Catholic School property that represents values contrary to the Catholic Church. Do not let your fear of vicious false accusals of hate pressure you to concede on your true values of love. Let your trust in the Truth and the Light of Christ guide your conscience and your vote tonight; and if you are persecuted for your vote, remember the words that Jesus spoke in the Gospel according to John, Chapter 15, Verse 18, "If the world hates you, be aware that it hated me before it hated you." To Christ be the Glory. God bless you all.

Summary of key presentation points:

- Christ died and rose from the dead out of His love for ALL people, including gay and trans people.
- Why is the pride flag being urged for placement in Catholic Schools to show love and respect to gay and trans students, when Christ's sacrifice already does that?
- Our focus should be to help remedy whichever challenges that gay and trans students are burdened with, and engage with them and the community at large in concrete solution-focused dialogue, with Christ's love as our focal point.
- Empty fanfare and do-nothing symbolism like the pride flag does not provide any remedy to the plights that gay and trans students may be facing.
- The pride flag also carries a payload of fornication and debauchery contrary to the Catholic faith.
- We must not be coerced into conceding on our values of love, just to avoid false accusals of hate.
- Stand with your convictions, and allow Christ to guide your conscience.
- Vote NO to pride flags being raised at Catholic Schools.

If Applicable, your key recommendations/suggestions to address the problem/issue:

Instead of engaging in do-nothing symbolism, especially symbolism like the pride flag which also carries a payload of fornication and debauchery contrary to the Catholic faith, we must give a declaration of intent to remedy whichever challenges that gay and trans students are burdened with, engage in concrete solution-focused dialogue, and place Christ's love as our focal point for ALL students, including of course, our gay and trans students.

Specific Statement of Issue

I'd like to present a petition on behalf of concerned parents who are opposed to the pride flag being raised for the month of June. Our petition has well over 2000 signatures and everyone who signed did so with the intention that the board be made aware of the petition which has garnered more signatures than the petition that was presented in support of raising the flag.

Summary of key presentation points:

Just to present the petition and read it out loud. Currently we have 2269 signatures that were collected since April 28. We anticipate that many more will sign and I should have the final numbers for you at the next meeting.

If Applicable, your key recommendations/suggestions to address the problem/issue:

The petition reads as follows:

As Catholics, we are taught that we must love our neighbour and treat every individual as a child of God, accepted with respect, compassion and sensitivity.

Parents make a clear choice when they decide that their children will attend a Catholic school. They rightly expect that trustees, principals, teachers all partners in education will ensure that Catholic teaching is presented, lived and infused in all that we do. In that regard, the appropriate symbol that represents our faith, and the inclusion and acceptance of others, is the cross, which is visible at the entrance of every Catholic school. It is the primary symbol of our Christian faith.

We have created this petition to express opposition of flying the pride flag at schools for the month of June. Our kids should not be forced to celebrate anyones sexuality, and a flag will do nothing to keep anyone more safe. Its nothing more than a symbol of sexual celebration, completely inappropriate.

Catholicism and parental rights are being threatened, and we will not allow teachers who are LGBTQ to influence our children.

We are not homophobes. We are trying to shield our children from any sexual ideologies, both gay and straight. Children are

minors who have a right to a normal and innocent childhood. We are not STAKEHOLDERS. We are parents. EQUITY is not and will never be the same as EQUALITY. Inclusion means EVERYONE and the York Region Catholic District School Board & its Union members are infringing upon our religious beliefs by suffocating our children with woke political agendas & indoctrinations when they should be focusing on educating our kids!

We love all humans equally. Hate is the wrong word to describe parents feelings about the climate in schools today. Parents protesting the pride flag at school do not harbour any negative feelings towards the LGBTQ+ community.. We do however feel that their rights seem to supersede everyone elses. We also believe that kids should never learn about sex at school and we condemn any classroom discussion or public display that encourages or promotes gender confusion and same sex lifestyles in a classroom setting. We also strongly condemn the nature of several library books that contain sensitive material on homosexuality and transgender issues in elementary school libraries. Similarly, we harbour no contempt for transgenders as individuals but their insistence on using female-only spaces is invasive.

The promotion of a pride sticker and the likelihood that a flag will go up in June at all schools suggests a particular political agenda, which warrants examination. Concern about alleged incidents of bullying directed at the LGBTQ community within schools has been raised. However when requesting specific information on the actual number of such reports, it was communicated that the data is currently confidential and not publicly available. Despite clarifying that only the number of incidents was desired, the same response was given.

The lack of transparency and information provided by the York Region Catholic District School Board concerning alleged incidents combined with these extreme campaigns using safe space stickers to promote political agendas, raises necessary questions about their motives. Despite facing opposition from relevant individuals, including the Archbishop of Toronto and Cardinal Collins, who have both explicitly expressed their disapproval of such displays, the union and its members have vehemently insisted the stickers remain.

We must stand up against this before the Board caves to the pressure of political correctness and decide to raise the pride flag too.

Please share this. We must get as many signatures as possible before May 20th so that we may present a united front at this months meeting with this petition in hand that will speak for itself and will represent all of us.

<p>Our proposal has 4 goals to address faith development and inclusion for all our staff, students and YCDSB families.</p> <p>1) YCDSB should explicitly dedicate the month of June to the Sacred Heart of Jesus. This follows an almost 200-year tradition in the Catholic Church beginning in 1856, when Pope Pius IX declared the month of June to the Sacred Heart of Jesus. However, devotion to the Sacred Heart of Jesus goes back to the Early Church Fathers in the first centuries of Christianity.</p> <p>2) An image of the Sacred Heart of Jesus with open arms welcoming everyone to be displayed in a prominent</p>	

location in every school during the whole year. Furthermore, besides displaying it in each school, we would also encourage all classes to have the image displayed. Jesus told St. Margaret Mary Alacoque in his 9th of 12 promises: "I will bless those places wherein the image of My Sacred Heart shall be exposed and venerated".

3) AN INCLUSIVITY STATEMENT declaring that ALL OUR STUDENTS, STAFF AND FAMILIES of YCDSB are placed in the Safe Refuge of the Sacred Heart Jesus and the Immaculate Heart of Mary. Finding Transportation Efficiencies Thru School Bell Time Review

- Whereas** in a report to the Joint Board Consortium dated December 2014, staff stated the following: “Savings can result from changing some existing school bell times. Changing bell times would ensure that school bus routes operate as efficiently as possible and would allow for the re-use of existing vehicles.”
- Whereas** a process for School Bell Time Management was developed and presented to the Joint Board Consortium dated June 2015. It recommended that parents were notified no later than December for changes to be implemented the following September
- Whereas** the implementation of the process was postponed indefinitely, ie never implemented, because Student Transportation Services wanted to implement new routing software which would make modeling easier.
- Whereas** the new transportation funding model did not adequately address the YCDSB’s transportation funding shortfall
- Whereas** the board has a deficit and other boards have found significant savings by undertaking a system wide review. For example, Durham DSB and Durham Catholic DSB saved \$1.9 M in 2017 and took 48 buses off the road after implementing a system-wide bell-time review. In 2022-23 they undertook a second study to find further savings since school demographics and riderships had changed.
- Whereas** reducing the number of buses will help address the bus driver shortfall.

LET IT BE RESOLVED

THAT Student Transportation Services undertake a bell time review to find transportation efficiencies with a report to come to the Board for September 2024 implementation.


