### 2023-24 Key Messages

- The in-year deficit has grown from \$12.9M (at Revised Estimates) to \$18.6M, necessitating an updated request for Non-Compliant Deficit approval to be submitted to the Ministry.
- Prior year grant adjustments relating to 19/20 through 22/23, to fund retroactive salary and benefits, have significantly impacted 2023-24 results – both revenue and expenses.
- These retroactive adjustments relate to:
  - Bill 124, which was all paid in 23/24 except for Principal/Vice-Principals
  - Labour negotiations salary and benefit provisions have been made for OECTA, Principals/Vice-Principals and Exempt.

### **Accumulated Surplus / (Deficit)**

The accumulated deficit at the end of 23/24 is \$9.9M.

A **balanced budget** is deemed to be an in-year surplus or deficit not exceeding 1% of the GSN operating allocation. In 2023/24, 1% of the Board's GSN operating budget is **\$6.3M.**

**Report:** Status and Recommendation for the International Baccalaureate (IB) Program at Holy

Cross Catholic Academy

#### **Executive Summary**

This report recommends phasing out the International Baccalaureate (IB) Program at Holy Cross Catholic Academy due to substantial declines in enrollment across all grade levels, resulting in financial and operational challenges that make the program unsustainable. It is advised that the IB Program be discontinued after the current Grade 11 class graduates. This consideration aligns with the board's commitment to offering rigorous academic pathways while managing resources effectively.

#### Overview

The IB Program at Holy Cross Catholic Academy has reached a critical point due to a steep and consistent loss of students due to attrition. Current enrollment levels are insufficient to cover the program's costs, including IB membership fees, specialized teacher training, and required resources. With just 3 students in Grade 12 and 14 in Grade 11, projected numbers indicate further declines, making it increasingly difficult to justify the program's continuation.

#### **Background Information**

The IB Program has served as an enrichment option, preparing students for global-minded university-level coursework. However, it requires substantial investment, including annual membership fees, ongoing teacher training, and specialized resources, which has become unsustainable at Holy Cross given the low enrollment numbers.

#### **Current Enrollment Overview**

The table below illustrates the current student enrollment in the IB Program across the grades at Holy Cross Catholic Academy:

#### **Projected Enrollment**

Based on the current attrition rates observed across our four IB schools, we anticipate that the number of students in Grade 12 at Holy Cross next year may dwindle to < 4 students. Projected registration numbers also indicate this trend will likely continue in the coming years.

#### **Program Costs**

Maintaining the IB Program at Holy Cross Catholic Academy is costly, as the program requires:

- Payment for IB membership fees.
- Ongoing teacher training.
- Specialized resources to meet the unique demands of IB.
- Periodic school reviews mandated by the IB organization.

Given the declining student numbers, these costs are becoming increasingly difficult to justify, especially when the program's effectiveness and attractiveness are waning.

#### Recommendations

This approach will ensure that Holy Cross Catholic Academy continues to offer challenging academic opportunities aligned with both student needs and the board's financial priorities, while maintaining transparency and support for students and families during the transition.

If Trustees approve staffs recommendation to phase out IB, then staff would:

- arrange meetings with the parents and students of all current Grade 9 and 10 students to formally announce the change, address any concerns, and discuss alternative academic options.
- ensure that guidance counselors are available to meet with affected students and families individually to assist with academic planning.

#### Staff is recommending:

• THAT the Board approve to discontinue the IB Program at Holy Cross Catholic Academy after the graduation of the current Grade 11 cohort. This phased approach will allow a smooth wind-down of the program without impacting students who are already enrolled.

**Report:** Introduction of Advanced Placement (AP) Program at St. Katharine Drexel CHS

#### **Executive Summary**

This report recommends implementing the Advanced Placement (AP) Program at St. Katharine Drexel Catholic High School (SKD) in Stouffville. Adding AP will enhance SKD's academic offerings, attract students interested in advanced learning opportunities, and enable the school to compete more effectively with nearby public schools that provide AP. This proposal requires no additional budget allocations, as SKD has both qualified staff and sufficient student interest to initiate the program. AP is also a very popular program with our secondary French Immersion students, in fact SKD is the only high school in our Board that offers FI but does not offer AP. Introducing AP at SKD will strengthen enrollment and support the school's long-term success within the competitive educational landscape of Stouffville.

#### **Background Information**

The AP Program is a globally recognized curriculum designed to prepare high-achieving high school students for university-level coursework. Students enrolled in AP courses may gain advanced standing in college or university based on their AP exam scores. Currently, eight YCDSB schools offer AP: Father Bressani CHS, Sacred Heart CHS, St. Maximilian Kolbe CHS, St. Joan of Arc CHS, St. Brother Andre CHS, Our Lady of the Lake CA, Our Lady Queen of the World CA, and St. Theresa of Lisieux CHS.

AP has proven successful across the board, enhancing academic rigor and encouraging student achievement. By expanding AP to SKD, we align with the board's commitment to broadening learning opportunities and fostering academic growth. SKD has the resources and expertise necessary to support this program effectively, and there is ample student interest to ensure sustainability without incurring additional costs. Upon review, the school will be able to run AP sections within the current staffing formula with existing qualified staff and therefore this recommendation has no impact on the Board's financial situation.

#### Recommendation

THAT the Board approve the introduction of the Advanced Placement (AP) Program at St. Katharine Drexel Catholic High School for the 2025-2026 academic year at no additional cost to the Board.
