**2024:012 DIRECTOR'S COMMENTS**

Director Scuglia started by acknowledging the error in electing the YCDSB Board Chair at the November 20, 2023, Inaugural Board Meeting and invited the appointed parliamentarian, Gillian Tuck-Kutarna, to offer her explanation.

Gillian Tuck-Kutarna remarked as follows:

*"Thank you very much, Director, and thank you all for the opportunity to address you tonight. As the Director said, I made an inadvertent error in calculating the votes that were cast on Monday night. And so I wanted to apologize to you privately on Monday night. I appreciate the chance to do so publicly tonight and to particularly apologize for the stress and inconvenience that were caused by the error and especially to the candidates involved. It's a stressful experience to put your name forward as a candidate for a leadership role. And I appreciate you doing that. Again, I'm sorry for my role in making that any more stressful than it had to be. In particular, I just wanted to clarify publicly that it was my error and not anything that the Board of Trustees were responsible for. I know that you've made considerable efforts over the years to ensure that your process is fair and that it's not only fair to the candidates, but seen to be fair. It was to that end that you decided to email your votes as a way of making sure that your process was beyond reproach. Unfortunately, in my case, it was not beyond human error. My apologies again for my part in that. Thank you for the opportunity to express that to you tonight."*

Director Scuglia thanked Ms. Tuck-Kutarna and reiterated that the error resulted from a third-party agency outside of the York Catholic District School Board. The Trustees and Senior Administration want to reassure the public that they can continue to have complete confidence in how the election was conducted. As a result of Monday, staff have reviewed the process again and made changes to ensure what transpired is not repeated. We apologize for any inconvenience and confusion caused by the error.

**2024:013 ELECTION OF OFFICERS FOR YEAR 2023-2024**

*"We will now turn our attention to the task of electing our Board Chair for 2023-2024. Our Operating By-Law #1, Section 2, states that the Director of Education shall preside until the election of the Board Chair.*

*The following are the procedures for election:*

- *A seconder is NOT required for nomination.*
- *Trustees joining the meeting remotely will be permitted to be nominated as Chair.*
- *Trustees joining the meeting remotely may participate in the secret ballot process.*
- *All nominees will be permitted to address the Board members before voting commences for a maximum of two minutes each.*
- *All nominators will be permitted to introduce the nominee for a maximum of one minute.*
- *Election shall require a clear majority of the votes cast.*
- *Votes will be emailed to the Board's legal counsel who has joined the meeting to oversee the voting process. (Welcome to our Legal Counsel, Melissa Eldridge)*
- *In the event of three or more candidates, the candidate receiving the lowest number of votes will be eliminated, and another vote will be held until there is a clear majority.*
- *In the event that there are three or more candidates – and after the vote there is still no clear majority - but there is a tie between the candidates receiving the lowest vote -- so that no candidate can be eliminated -- a second vote by ballot will be held.*
- *If there is still a tie after that vote, I will draw lots between the candidates who have a tie vote, and the candidate whose name is drawn will be eliminated.*
- *In the event of two candidates and after the vote there is no clear majority, a second vote by ballot will be held.*
- *If there is still a tie after that vote, I will draw lots between the candidates that have a tie vote, and the candidate whose name is drawn will be eliminated.*

**a) Election of Chair of the Board**

The Director called for nominations for the office of Chair of the Board.

Nominations:

Elizabeth Crowe accepted the nomination.
- ii) Joseph DiMeo nominated Frank Alexander.  
Frank Alexander accepted the nomination.

The Director repeated the call for nominations for Chair of the Board thrice. Nominations for Chair of the Board were closed on **Motion by Cotton/DiMeo** and **CARRIED**.

Vice-Chair Iafrate asked the Director to ask Ms. Gillian Tuck Kutarna to disconnect from the meeting to ensure no confusion.

Gillian Tuck-Kutarna disconnected at 5:10 pm

D. Scuglia, Director of Education, invited each candidate to address the Board of Trustees for a maximum of two minutes before voting commenced.

The Board of Trustees emailed Legal Counsel directly with their vote.

The vote resulted in a tie. Therefore, a second casting of vote was submitted electronically to the Board's Legal Counsel.

The second vote resulted in a tie. Therefore, as per 2.2(c)(i) of the Board's Operating By-Law, a vote was held by drawing lots. The ballot was drawn in clear view of all present including legal counsel that had joined virtually. Trustee Alexander's name was drawn from the box and therefore he was eliminated.

**The Director declared Elizabeth Crowe, Chair of the York Catholic District School Board for the year 2023-2024.**

Director Scuglia recognized outgoing Chair Frank Alexander for his hard work over the last year and his leadership, his passion for Catholic education, and his servant leadership to the Board. Director Scuglia wished Trustee Frank Alexander continued success as Trustee for the Board.
