of its determination and sanctions;

WHEREAS the Board has considered the written submissions of Trustee McNicol's counsel

dated October 13 and 25, 2023;

WHEREAS the Board of Trustees has met to reconsider its determination and sanctions of

September 26, 2023, and in doing so, has considered the submissions of Trustee

McNicol.

LET IT BE RESOLVED THAT:

- The Board of Trustees' determination that Trustee McNicol has breached Policy 118, the Trustee Code of Conduct is upheld;
- b. The sanctions imposed on Trustee McNicol for her breach are varied as follows:

- c. Effective November 7, 2023 and ending with her term of office on November 14, 2026, that Trustee McNicol be barred from attending or sitting on all Committees of the Board during that period.
