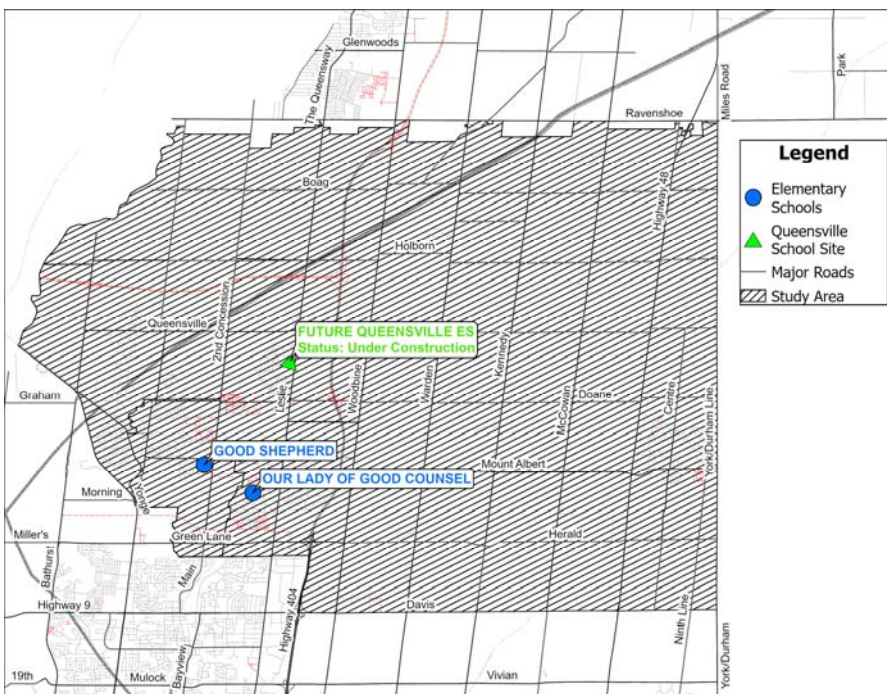
### Summary

Construction for the new unnamed Queensville Catholic elementary school commenced in July 2025 and is anticipated to open for September 2027.
