Throughout the school year, the York Catholic District School Board (YCDSB) recognizes different virtues that are central to our faith and our actions as Catholics. In October, we recognize compassion. The Gospels recount many occasions when Jesus showed compassion for the sick, poor and distressed. In our schools, students are called to show their compassion by understanding others through listening, being willing to forgive others and helping those in need. #### Long-Term Accommodation Plan (LTAP) Update

From May 30 – June 1, 2024, this beautiful conference theme led the CCSTA Board of Directors and more than 200 participants from across Canada through the 3-day gathering in downtown Calgary. The official conference opening took place Thursday evening with a warm welcome to Calgary, opening prayers and blessings and an outstanding keynote presentation by Father Cristino Bouvette, entitled "Reconciliation is Possible: The contribution of Catholic Education towards Reconciliation with our Indigenous People".

Fr. Cristino shared a heartfelt presentation of his own personal experience of working towards Truth and Reconciliation within our Church and communities. Throughout his presentation, he offered unique and insightful perspectives to Catholic educators and encouraged members to strive for authentic dialogue when it comes to reconciliation efforts within school communities. A standing ovation immediately followed his presentation – affirming his thoughtful articulation of an important and relevant topic to Catholic educators across Canada.

Friday morning opened with an engaging Keynote called, "Who's Driving the School Bus?" by Certified Management Consultant and author, Ian McCormick. Mr. McCormick offered his experience and expertise to participants through practical advice on how to set up successful board practices, host engaging, efficient meetings and collectively ensure goals are met throughout the school year.

The next keynote speaker was Dr. Bob Murray, who presented on the fascinating and timely topic of "Maintaining the Gift of Catholic Education in an Era of Political Polarization". Dr. Murray provided participants with an overview of the current political landscape in Canada and shared helpful tips for Catholic schools and school board trustees who are navigating the polarizing debates and realities found within our Catholic education system. He reminded trustees of the importance of unity within our Catholic school system and its crucial role in maintaining the future of Catholic schools in Canada. Participants had the opportunity to choose from and attend multiple workshops Friday afternoon ranging in topics from fostering Catholic culture to insights from the work of Truth and Reconciliation within the Calgary Catholic School District.

Our Saturday morning session began with Dr. Kate Mallon, director of Grateful Advocates for Catholic Education in Alberta, as the final keynote speaker for the conference. Her keynote presentation, entitled, "Courage to Lead", encouraged members to continue advocating for the rights of Catholic schools in Canada and the maintenance of Catholic identity in our schools. Dr. Mallon emphasized the gift of Canadian Catholic Education and reminded participants of the importance of cultivating a personal prayer life as a Catholic school trustee or board member. The annual AGM followed the keynote.

The 2024 Gala Banquet was enjoyed by all Saturday evening! Our 2024 Justice James Higgins Award recipient, Julian Hanlon, was acknowledged (though unable to attend in-person!), a live auction was held for Toonies for Tuition and CCSTA President Teresia Chiarella gave a warm and encouraging address to members.

Throughout the event, there were opportunities for attendees to connect with other trustees and board members from across Canada to offer encouragement, solidarity and support in the mission of Catholic education. We're extremely grateful to the organizing committee at Calgary Catholic School District for hosting an unforgettable AGM.

I am always so happy to see our students and staff praying the rosary together in school. The habit of praying the rosary can be a life-changing devotion, and I owe a debt of gratitude to our staff, who share this holy practice with young people.

#### Recognizing Our Amazing Staff

I started my teaching career at York Catholic, and then had the privilege of traveling around the province working for many other public and private organizations. Based on those experiences, I know that York Catholic staff are special people who are dedicated to the mission of Catholic education. For that reason, I am thrilled that several days are set aside in the calendar throughout the year to recognize the vocations our staff have committed their lives to. In particular, we have recently or soon will celebrate:

- September 17: IT Professionals Day
- October 2: National Custodians Day
- October 5: World Teachers Day
- October 17: Bus Drivers Appreciation Day (although our transportation services are contracted, we are grateful for those individuals who get our children safely to and from school)

#### September 27, 2024: Faith Day

A cherished tradition in the York Catholic District School Board (YCDSB) is Faith Day. It is a PA Day dedicated solely to the adult faith development of our staff. Principals have developed a day of programming that will inspire reflection, celebration and connection with our faith. As I said in a message to our staff for Faith Day, in a world where young people increasingly suffer from a lack of connection with others, seeing an adult living their faith could be the light they need to guide them to a better place. I hope everyone has a fulfilling Faith Day!

#### **Updated Joint Police Protocol Signing**

On September 19, I joined York Regional Police Chief Jim MacSween, York Region District School Board Director of Education Bill Cober and a French Catholic school board representative at the Community Safety Village in Whitchurch-Stouffville to sign an updated joint police protocol. The Ministry of Education requires school boards and local police departments to have a protocol that will oversee the police's involvement in schools while they investigate alleged violations of the criminal code.

After reviewing and discussing the protocol with our community, we decided it was time to update it to provide school staff and the police with a shared understanding of police involvement in schools through joint training. The updated protocol also calls for community safety practices in schools to use a trauma-informed, anti-racist, and anti-oppressive approach.

During that press conference, there were mentions of seven new presentations that the YRP have developed for school audiences on age-appropriate, fact-based safety topics. In that press conference, I made it clear that the YCDSB will seek the feedback of our community members before we proceed with those presentations. We must build trust in this presentation process before they are used in our schools.

#### Fundraiser for National Day for the Elimination of Poverty

I am so grateful for our attendance counsellors who recently came forward with an excellent idea: to use the National Day for the Elimination of Poverty on Thursday, October 17, 2024, as a civies day to raise funds to help our students who have difficulties attending school because of financial need. On October 17, students in schools with uniforms or standard dress can donate a loonie or a toonie to wear civies. Schools without uniforms or standard dress are encouraged to develop their own fun themes to raise money for this worthy cause. That money will then be used to create a more equitable learning environment in our schools. This is a perfect example of how creative thinking can be used to live our Gospel values by helping those in our community.

#### National Day for Truth and Reconciliation

As a Catholic learning community, the YCDSB will use September 30, the National Day for Truth and Reconciliation, to learn more about the Indigenous peoples of this land and the trauma they have experienced. Pope Francis' apostolic journey to Canada in 2022 has been a call for all Catholics to journey with our Indigenous brothers and sisters on this path to reconciliation.

#### Walk to School with Mayor Del Duca

On Wednesday, October 2, some of our Trustees and I will join Vaughan Mayor Steven Del Duca on a walk to school to celebrate IWALK Day. We encourage everyone who can use active transportation to travel to and from school; it is good for your health, it is good for the environment and reduces traffic congestion in our neighbourhoods. We will walk from Davos Road Park to Kingsview Park starting at 8:10 a.m. to show how fun it is to use walk/run/roll to school. I hope you will join us!

#### **OSTA-AECO Catholic Cabinet**



#### **Executive Summary**

This report is providing proposed By-Law Changes with respect to the *Better Schools and Student Outcomes Act, 2023,* and *O. Reg 313/24* which amended to *O. Reg. 463/97:* Electronic Meetings and Meeting Attendance to promote and enhance accountability, transparency, and public confidence in the education system. The suggested revisions were brought for information at the August 27, 2024 Regular Board meeting and are now coming for action. Please note that changes to clause 3.1 and 3.1.7 have been added to incorporate comments from the August Board meeting.

A: Changes dealing with Meeting Attendance at Regular Board Meetings and Regular Committee of the Whole Meetings:

#### 3.1 Regular Public Meetings

Regular Public Meetings of the Board and start time for those meetings shall be held as determined by the Board and shall be communicated to the public prior to the meetings on the Board website, but no later than the date that Trustees receive the agenda. If in any month there is no regular meeting(s), there shall be a regular meeting in the next following month, or as otherwise decided by the Board or Executive Committee.

The schedule for all Regular Board Meetings shall be an information item on the Regular Board Agenda in May of each year, for the following school year. There shall be a minimum of ten scheduled Regular Board Meetings starting at 7:30 pm.

#### 3.1.1 When and Where Held

Regular meetings of the Board shall be held in the Board Room of the Catholic Education Centre, Aurora, Ontario, unless otherwise determined by the Board or Executive Committee. and shall be open to permit the physical attendance by members of the public.

- 3.1.1.1 All public Board and committee meetings shall be live streamed.
- 3.1.1.2 The Board shall provide members of the public with electronic means to make Delegations to Board and Committee meetings.

#### 3.1.2 Attendance

Attendance at meetings shall be in person or by electronic means. All members of the Board shall be physically present in the meeting room of the Board at every regular meeting of the Board and every regular meeting of the Committee of the Whole Board. A member of the Board may participate by electronic means if the member receives written approval before the meeting begins as follows:

- (a) The member of the board shall submit a request in writing and the reasons for the request to the Chair of the Board at least one hour before the meeting begins
- (b) If the Chair is making the request to participate by electronic means then the request will be submitted to the Vice-Chair.
- (c) The request may be approved if one or more of the following circumstances exist:
  - *(i) Weather conditions do not allow the member to travel to the meeting location safely*
  - *(ii)* The member cannot be physically present due to health-related issues
  - *(iii)* The member has a disability that makes it challenging to be physically present at the meeting
  - *(iv)* The member cannot be physically present due to family responsibilities in respect of *i. the member's spouse,* 
    - ii. a parent, step-parent or foster parent of the member or the member's spouse,
    - *iii. a child, step-child, foster child, or child who is under legal guardianship of the member or the member's spouse,*
    - iv. a relative of the member who is dependent on the member for care or assistance, or
    - *v. a person who is dependent on the member for care or assistance and who considers the member to be like a family member.*

(d)The Chair shall not approve a request if fewer than one member of the Board in addition to the Chair of the Board or their designate, will be physically present in the meeting room. The Vice-Chair shall not approve the Chair's request unless the Chair's designate is physically present. NOTE: At all times at least 2 members must be physically present.

3.1.2.1 At all meetings of the Board and of the Committee of the Whole Board, in addition to the usual requirements for quorum, the physical presence in the meeting room at the Catholic Education Centre shall be required of:

(a) The Chair or designate of the Board;

(b) Not less than one other Trustee, other than the Student Trustee; and,

The Director of Education or his/her designate.

3.1.2.1 (new)

At all meetings of the Board and of the Committee of the Whole Board, the physical presence in the meeting room at the Catholic Education Centre shall be required of the Director of Education or their designate. This requirement is waived only for Committee of the Whole meetings where the only item on the agenda is the Director's Contract and/or their Performance Appraisal.

3.1.2.2 The Chair of the Board may participate in a meeting of the Board or of a Committee of the Whole Board by electronic means if:

(a) Weather conditions do not allow the Chair to travel to the meeting location safely; or,
 (b) The Chair cannot be physically present at a meeting due to health related issues.

# 3.1.2.3 (a) If the Chair is not physically present then the Vice Chair will act as designate (3.1.2.1a). **NOTE:** At all times at least 2 Trustees must be physically present.

#### 3.1.2.2

Notwithstanding 3.1.2 The Chair or Vice Chair (as designate) must be physically present for at least half of the Board meetings, including Committee of the Whole, for any twelve month period beginning November 15<sup>th</sup>.

#### 3.1.2.3

A trustee shall be physically present in the meeting room of the board for at least three regular meetings of the Board during each twelve-month period beginning November 15. For clarity, a trustee must be physically present for at least one regular meeting of the Board for each period of four full calendar months ending the following November 14th.

#### 3.1.2.4

The requirements for persons to be physically present at meetings do not apply if all schools are closed pursuant to an order (*O Reg 313/24 Section (10*))

#### 3.1.7 Private Sessions (Committee of the Whole Board)

Private Session shall be held either before or after the Regular Public Meeting of the Board <del>as determined by the Executive Committee</del>, starting no earlier than 6:30 pm. An earlier start time may occur, if necessary, due to extenuating circumstances with prior approval of the Executive Committee.

#### **B:** Changes dealing with Committee meetings:

#### 4.1.6 Meetings

Committee meetings shall be held on dates selected by the committee, the committee Chair or the Executive Committee of the board. Notice of meetings will be circulated to all Trustees

#### 4.1.6.1 (new)

All Committee meetings shall be held in a room at the Catholic Education Centre, except for the Joint Board Consortium, whose meetings alternate locations between YCDSB and YRDSB.

#### 4.1.6.2 (new)

All Committee meetings shall be open to permit the physical attendance by members of the public unless they deal with matters that are to be dealt with in private session (By-Law 3.1.8 and clause 207 (2) (b) of the Education Act).

**THAT**4.1.6.2 (a). (new) All Committee meetings open to the public shall be live-streamed.

#### 4.1.7 Attendance

Attendance at meetings shall be in person or by electronic means.

- 4.1.7.1 At all committee meetings, in addition to the usual requirements for quorum, the physical presence in the meeting room at the Catholic Education Centre shall be required of:
  - (a) The Chair or designate of the committee
  - (b) The Director of Education or his/her designate
- 4.1.7.2 The Chair of a Committee may participate in a meeting by electronic means if:
  - (a) Weather conditions do not allow the Chair to travel to the meeting location safely; or,
  - (b) The Chair cannot be physically present at a meeting due to health-related issues.
  - (c) (new)

*The Chair has a disability that makes it challenging to be physically present at the meeting (d) (new)* 

*The Chair cannot be physically present due to family responsibilities as listed in By-Law 3.1.2* 

*4.1.7.3 (a) If the Chair is not physically present then the Vice Chair will act as the designate and will Chair the meeting. (4.1.7.1a)* 

(b) If neither the Chair nor the Vice Chair are physically present, then a committee member present at the Catholic Education Centre shall be elected Chair for the purposes of the meeting. If no committee member is physically present at the Catholic Education Centre, then the meeting will stand adjourned and will be rescheduled.
